- 3. It was resolved that the meeting of all the sub-committees shall be convened every alternate week to evaluate the progress of work of each committee and also to take necessary decisions regarding their future activities.
- 4. The NSC unanimously decided that, henceforth the conference room on the first floor of the Central Library of the University shall be used as the office of the NSC. The convener is advised by the Committee to apply officially to the Registrar for necessary approval. It was further decided that the university authorities shall be requested to furnish the said room with necessary infrastructural aids, such as two desktops with printer- cum-scanner machines and Internet facilities.

- 5. It was resolved that the university authorities will be requested officially by the Convener, NSC to grant the NAAC Steering Committee a renewable fund of Rupees Ten Thousand (Rs. 10,000/-), on reimbursement basis, for the purpose of conducting NAAC preparation works hassle-free, till the completion of the entire accreditation process.
- 6. The Committee recommended that The Registrar must write to the NAAC Authorities for the extension of accreditation period of our University at the earliest.
- 7. The Committee requested the Registrar to collect the following data from the persons concerned:
 - I. Data collected by the PRO of the University for the preparation of Annual Reports, from 2020 to 2025, in digital format.
 - II. Data collected by Campus Technology, which they verbally reported to have been submitted to the then Registrar, Dr Ashis Kumar Samanta.
- 8. It was decided that, henceforth all the resolutions taken in the meetings of the NSC will be uploaded on the official website of the University.
