Candidates ('Persons with Benchmark Disabilities'), who want to write Written Examination for recruitment of non-teaching staff as per Recruitment Notice Estt./7129/2020 dated 12/02/2020 to be held on 29.05.2022 with Scribe may apply (as per Format attached) to the Registrar with below-mentioned necessary documents of the Candidate and the Scribe:

- 1. Original alongwith one self-attested photocopy of the Admit Card of the Examination of the Candidate.
- 2. Original alongwith one self-attested photocopy of the Certificate regarding educational qualification of the Candidate.
- 3. Original alongwith one self-attested photocopy of the Medical Certificate (i.e. 'Persons with Benchmark Disabilities' Certificate) of the Candidate.
- 4. Original alongwith one self-attested photocopy of the Certificate regarding educational qualification of the "Scribe'.
 - (The candidate will have to arrange his/her own scribe at his/her own cost and the qualification of the scribe should be one step below the essential qualification as mentioned in the Recruitment Notice Estt./7129/2020 Date: 12/02/2020 for each category of posts (Grade-I and Grade-II). If the Scribe presently is not a student, then he has to submit a certificate mentioning the same from a competent Govt. authority.)
- 5. Two recent colour Photograph of the Candidate (to be pasted in the application form).
- 6. Two recent colour Photograph of the Scribe (to be pasted in the application form).

Note:

- Please ensure that you are eligible to use a scribe as per Government of India Rules governing the
 recruitment of persons with disabilities. In case it later transpires that the candidate does not fulfil
 any of the laid down eligibility criteria or suppresses material facts, the candidature of the applicant
 will stand cancelled, irrespective of the result of the examination.
- 2. Candidates ('Persons with Benchmark Disabilities') must submit their application form for Scribe at least 3 (three) working days prior to the date of examination. Without prior approval, no scribe/amanuensis shall be allowed in the examination hall.
- 3. After receiving the permission from the competent authority of the University, Candidates ('Persons with Benchmark Disabilities') will be allowed to write Examination with Scribe (vide F. No. 34-02/2015-DD-III, dated 29.08.2018 of Ministry of Social Justice & Empowerment, Govt. of India, and The Rights of Persons with Disabilities Act, 2016) with 20 minutes per hour of examination on prorata basis as 'Compensatory Time'.
