Rabindra Bharati Journal of Political Science is a double-blind peer-reviewed journal published by the Department of Political Science, Rabindra Bharati University, Kolkata. **Research Articles** not exceeding 6,000 words, **Commentaries** not exceeding 2000 words, and **Book Reviews** not exceeding 1500 words (including notes and references) are invited from scholars, researchers and teachers for its **Volume 18, 2025**. Submission of a paper implies that it is an original unpublished work and is not being submitted for publication elsewhere or has been published elsewhere.

#### Submission Guidelines

**Format and Font:** Authors should prepare their manuscript using Microsoft Word, Times New Roman 12 font, double spaced with adequate margins in the left-hand side.

**Authorship:** On a separate title page at the beginning, author(s) should mention their name(s), affiliation, designation, e-mail, and contact number.

**Declaration:** Author(s) must declare that the paper has not been published/considered for publication elsewhere.

**Abstract:** Not more than 200 words with maximum 5 keywords at the beginning of the paper.

**Writing paper in English:** British English or English UK is to be followed, particularly in case of spellings.

**Style of Reference:** The APA 6<sup>th</sup> referencing with parenthetical style. For example:
